B. Guidelines for Empanelment of Contractors in LDA

In order to empanel firms/contractors having technical and financial capability competent with the requirements of work, the guidelines for empanelment of contractors/firm are outlined hereunder :

B.1. Eligibility criteria :

i. Contractors/firms should be registered under Central Govt./CPWD/PWD/IFCD/PHED/ Power Dept. of Govt. of Manipur Pvt. Ltd. Company registered under the Ministry of Company Affairs. Relevant registration certificate should also be furnished as required in **Form-A.**

- ii. The contractor/firm should have a minimum average annual turnover of Rs.250.00 lakh(for special class), Rs.100.00 lakh(for class-I contractors), Rs.50.00 lakh(for class-II) & Rs.30.00 lakh(for class-III contractors) during the last 3(three) consecutive financial years. Information is to be supported by copy of Income Tax Return, balance sheet and profit & Loss Account Statements duly audited/certified by Chartered Accountant for the said financial years.
- iii. Have a valid Financial Solvency of not less than Rs.250.00 lakh(for special class), Rs.100.00 lakh(for class-I), Rs.50.00 lakh(for class-II) and Rs.30.00 lakh(for class-III). The solvency certificate is to be issued by a Scheduled/Nationalized Bank within last 6 months from the last date of submission of application.
- iv. The contractor/firm should have a minimum five years' experience as on **31-03-2023** in execution of original civil/mechanical/electrical works in Central Govt., State Govt. and PSUs. They should mandatorily possess the following eligibility criteria :

B.2 Special Class :

i. The contractor/firm who is registered as a special class contractor under Central Govt./CPWD/PWD/IFCD/PHED/Power Dept. of Govt. of Manipur, PSUs under Govt. of India/Govt. of Manipur should have successfully completed Rs.300.00 lakh(gross value) of works during the last 3(three) years on the date of application.

B.3. Class-I

The Contractor/firm who is registered/enlisted as a class-I contractor under Central Govt/CPWD/PWD/IFCD/PHED/Power Dept. of Govt. of Manipur, PSUs under Govt. of India/Govt. of Manipur should have satisfactorily completed Rs.100.00 lakh(gross value) of works during the last 3 years on the date of application.

B.4. Class-II

The contractor/firm who registered/enlisted as a class-I contractor under Central Govt./CPWD/PWD/IFCD/PHED/Power Dept. of Govt. of Manipur, PSUs under Govt. of India/Govt. of Manipur should have satisfactorily completed Rs.50.00 lakh(gross value) of works during the last 3 years on the date of application.

OR

Authorized sub-contract/firm who has the above eligibility criteria.

B.5. Class-III

The contractor/firm who registered/enlisted as a class-I contractor under Central Govt./CPWD/PWD/IFCD/PHED/Power Dept. of Govt. of Manipur, PSUs under Govt. of India/Govt. of Manipur should have satisfactorily completed Rs.30.00 lakh(gross value) of works during the 3 years on the date of application.

OR

It will be the entry point for empanelment of individual/firm who has not less than Rs.30.00 lakh in his/its account.

- **2. UPGRADATION :-** Any contractor who has already empanelled in LDA may be upgraded to next upper class if he/she satisfies the eligibility of that upper class criteria.
- 3. The applicant shall submit copies of GST & PAN certificates.

- 4. The Contractor/firm should submit duly filled in and signed application form as given in **Form-A** and financial details as given in **Form-B**.
- 5. A work order along with a work completion certificate in proof of work issued by the employer and work successfully completed by the contractors shall be submitted. The applicant shall furnish list of past works executed with the names of clients/utility in the format given at **Form-C**.
- 6. The contractor/firm shall submit details of past contractual performance as given in Form-D.
- 7. The bidder should not be debarred/blacklisted in any Central/State Government departments as on the date of bid submission date. Undertaking for the same shall be submitted in format Form-E.
- 8. The bidder shall submit Format A to E duly filled in with certified supporting documents and credentials along with other information/date according to check list enclosed qualification.
- 9. The evaluation will be carried out by a Committee constituted for the purpose by LDA and will be based on the eligibility criteria, expertise, work experience, technical & financial capability and valid documents submitted by the applicants. Decision of LDA regarding selection/rejection for empanelment will be final and binding and no further correspondence will be entertained. Even though an applicant may satisfy the above requirement, he would be liable to be disqualified if he has :
 - a. Made misleading of false representation or deliberately suppressed the information in the forms, statement and enclosures required in the pre-qualification documents.
 - b. Record of proof performance such as abandoning the work, not properly completing the contract, or financial failures/weakness etc.

- C.2. All empanelled firms/contractors shall pay onetime non refundable empanelment fees to LDA, Imphal at the rates as detailed above in the form of demand draft in favour of the "LOKTAK DEVELOPMENT AUTHORITY" at the time of submission of application forms.
- **C.3**. All empanelled firms/contractor shall however be liable to pay non-refundable renewal fees on further extension of their empanelment period(five years at a time) as detailed below :-

C.4. Contractor shall apply for revalidation/renewal 2(two) months before the expiry of the empanelment period.

- 10. The LDA will notify the empanelled list within 2(two) weeks time provided all the relevant papers/documents submitted by the contractor/firm are found to be in order or in line with the criteria and qualification's as sought by the competent authority of LDA.
- 11. The qualified contractor shall submit a non-refundable fee as given in **Clause-C Table C.1** wherever applicable to the contractor as per notification within 1(one) week time. The fee should be deposited in the form of DD in favour of "LOKTAK DEVELOPMENT AUTHORITY".
- 12. Under any unavoidable circumstances if the competent authority of the LDA could not finalize the empanelled list within the time given in **Clause-II** the fee will be reimburse to the person concerned/contractor from LDA in the earliest possible time. However, the cost of application form submitted towards LDA is non-refundable under any conditions.

B. Instructions to Bidders

- **D.1** Format and signing of Bid :
 - a. The bid must contain the name and address of the person or persons making the bid and must be signed and sealed by the bidder with his usual signature. The names of all persons signing should be printed below the signature.
 - b. Bid by a partnership must be furnished with the full names of all partners and be signed with the partnership name, followed by the signature(s) and designation(s) of the authorized partner(s) or other authorized representative(s).
 - c. Bids by Corporation/Company must be signed with the legal name of the Corporation/Company by the President, Managing Director or by the Company Secretary or other person/persons authorized to bid on behalf of such Corporation/Company in the matter.
 - d. Satisfactory evidence of authority of the person signing on behalf of the Bidder shall be furnished with the bid.
 - e. The bidders/name stated on the proposal shall be the exact legal name of the firm.
